VOLUNTEER AGREEMENT

REV. 4/5/2004

In consideration of this opportunity to volunteer, I agree to the following terms and conditions:

- I understand and agree that Animal Heartline Humane Association has the right to refuse volunteer applications for any reason.
- I will abide by the mission, rules, regulations, policies and programs of Animal Heartline Humane Association while I am a volunteer.
- If I stop being a volunteer for Animal Heartline Humane Association for any reason, or upon request from the organization to resign as a volunteer, I will promptly return all supplies, equipment, records, moneys, and other items in good clean condition within five (5) days.
- If I will be sheltering, providing foster care and/or boarding any animals for Animal Heartline Humane Association in my home or business, I consent that Animal Heartline Humane Association may visit my home and business from time to time to observe the animals and their living conditions. Visitations may be unannounced.
- I assume the risks of being bitten, scratched, injured or frightened by animals in connection with my volunteer work with Animal Heartline Humane Association.
- I am signing this waiver of liability in the event of injury, death or damage to personal property or self while volunteering for Animal Heartline Humane Association which may be incurred while acting in a volunteer position and capacity. I do hereby agree to hold Animal Heartline Humane Association and its respective officers and members free from any and all liability, and do hereby for myself, my heirs, executors, and administrators, waive, release and forever discharge any and all rights and claims which I may hereafter accrue to me arising out of or connected with my participation in any of the activities or duties of Animal Heartline Humane Association.
- I understand that I may be asked to leave at any time, for any reason, and that my volunteer work will be overseen by the Volunteer Manager and the Board. If I commit a crime or break the rules during my service, I understand that I can be prosecuted as appropriate, disciplined, and/or required to revoke my privilege to serve as a volunteer.
- I agree to represent Animal Heartline Humane Association and to support the philosophy, to perform in a professional manner whenever so doing, and to refrain from allowing personal views and opinions from overshadowing or conflicting with Animal Heartline Humane Association's purpose. I do not have the authority to commit or obligate Animal Heartline Humane Association to any events, services, or products without permission from the Board.

Any modifications made to this Agreement must be in writing and signed by both parties. This Agreement is legally binding upon Animal Heartline Humane Association and myself and Animal Heartline Humane Association's and my respective heirs, executors, and administrators and personal representatives.
